2 **SERVICE OF MORNING PRAYER**

Rev. Dr. William Myers led the Service of Morning Prayer with a Meditation and scripture from Psalm 95:1-7 and Philippians 2:1-11.

3 **COMMITTEE ON REPRESENTATION AND NOMINATIONS**

3.1 Committee Chair, Rev. Karen Zurakowski, reported on behalf of the Committee—Ruling Elder Florence Morrison, Ruling Elder Maggie Tall, Rev. David Henderson, Rev. William Payne, and Rev. Karen Zurakowski. The Committee nominated to the Committee on Ministry Rev. Kenneth Krause (Harrisville/Spruce) Class of 2021 and Ruling Elder James Halsey (Pickford) Class of 2022. There being no nominations from the floor, Presbytery **VOTED** to elect the nominees as presented.

3.2 Committee Chair also reported that due to the resignation of the Rev. Sandra Murray, chair of the Committee on Missions, Committee Member Joseph Leach will be the acting chair of the committee.

3.3 She noted that there are numerous open positions and more openings in September as the Class of 2021 completes their terms. She requested presbyters to prayerfully look at their home congregations and see if God is pointing them toward someone in their congregation that may have the

4 **TRANSITIONAL SYNOD EXECUTIVE**

Transitional Synod Executive, Rev. Dr. Charles B. Hardwick, brought greetings from the Synod of the Covenant. He reported that the Synod is part of the Matthew 25 movement within the Presbyterian Church, USA, which is an effort to (1) build congregational vitality, (2) dismantle structural racism, and (3) eradicate systemic poverty. Synod of the Covenant ministries which help presbyteries, churches, and individuals make progress toward these three goals are higher education scholarships for Christian leaders, Ukirk, opportunities to train and equip preachers, leadership development workshops through LeaderWise including Racial Justice, Boundaries Training, Emotional Intelligence, Conflict Management, and Committee on Ministry and Committee on Preparation for Ministry training.

5 **BOARD OF PENSIONS**

Rev. Dr. Douglas Portz, Senior Church Consultant, brought greetings from the Board of Pensions. He expressed thanks for time on the docket in order to update presbyters on statistics and on the help provided by the Board over the last year with the COVID-19 pandemic and on the recent changes and the services available to Board participants. He reported that effective July 1, 2021, there will be a two percent (2%) increase in pension credits. He urged members to feel free to contact him with questions or for more information.

6 **YOUNG ADULT ADVISORY DELEGATE (YAAD) to the 224th GENERAL ASSEMBLY, PRESBYTERIAN CHURCH (U.S.A.)**

Henry Sale, career campus minister interim through Northern Michigan University, was the elected Young Adult Advisory Delegate (YAAD) to the 224th General Assembly which was held virtually for the first time on June 19, 20, 26, and 27, 2020, due to the COVID-19 coronavirus pandemic. YAAD Henry Sale reported verbally. He thanked the Presbytery for this opportunity. The YAADs formed a group chat and continue to communicate. The Assembly acted to approve as amended Item 00-29 *On the Church in this Moment in History—From the Committee on the Office of the General Assembly* on anti-racism (basis Isaiah 58:12). He stated that participating in General Assembly was an extraordinary experience.

7.2.5 **Association of Stated Clerks and Association of Mid Council Leaders (ASC/AMCL) Virtual Mid Winter Gathering**

The Association of Stated Clerks and Association of Mid Council Leaders Gathering was held virtually via Zoom for the first time on February 24 and 25, 2021. During the opening gathering, participants recognized the Native Lands upon which we stand.

Guest speaker was the Rev. Dr. Okokon Udo, founder and CEO of SoulEngineering, LLC, Getting to the Heart of the Matter. His two keynote addresses, *The Care of Organizations following Trauma* and *How Leaders Support Leaders* were followed with breakout room interaction. Stated Clerk, Rev. Dr. J. Herbert Nelson; Co-Moderators of the 224th

General Assembly, Ruling Elder Elona Street Stewart and Rev. Gregory Bentley; and President and Executive Director of the Presbyterian Mission Agency, Rev. Dr. Diane Moffett, each brought greetings and briefly addressed the gathering.

During worship, GA Stated Clerk, Rev. Dr. J. Herbert Nelson, delivered the Reflection: *The Church Never Closed!*

Approximately two dozen workshops on a variety of topics were offered, allowing us to choose only three. I attended a *Conversation with Kris Valerius, Manager, Denominational Rolls, Statistics and More; What Stated Clerks need to know to effectively interact with the Board of Pensions* with BoP Senior Church Consultants Rev. Dr. Douglas Portz and Elder T. Clark Simmons; and *Three Types of Councils*, a guided conversation with Rev. Dr. Craig Howard, Presbyterian Foundation, with questions to help determine the purpose, opportunities, and pitfalls of different council structures for those presbyteries who are considering restructuring.

The Synod of the Covenant is partnering with its eleven presbyteries to enable our participation. The Synod will be paying two-thirds the cost of each workshop, and participating presbyteries will divide the remaining one-third cost. Some of the workshops have an additional participation fee.

The Presbytery of Mackinac has committed to **Boundaries Training** and **Committee on Ministry/Committee on Preparation for Ministry**.

There are no additional participation fees for either of these workshops.

7.3 225th General Assembly (2022) June 18–July 9

Planning for the 225th General Assembly is ongoing as the Committee on the Office of the General Assembly (COGA) meets regularly. As of April 26, 2021, this is the basic flow of the Assembly:

Commissioners and advisory delegates on four committees will arrive in Louisville on Friday, June 17, 2022.

GA will convene on Saturday, June 18, with those commissioners and advisory delegates in person, and all others participating online.

During Plenary 1, those attending in person—enough present to constitute a quorum—will vote on a motion to authorize meeting electronically.

Once authorized by the action of the quorum, all subsequent actions will include those voting from remote locations as well.

Sunday, June 19, will focus on observance of Juneteenth.

From June 20 through July 2, four committees at a time will meet in Louisville for three days each. All will be live-streamed.

From July 5-9, plenary meetings will be held with the (co-)moderator(s) in Louisville, and all other participants online only.

- 9.2 PW Communicator thanked “everyone who replied to our letter seeking guidance about Presbyterian Women in the Presbytery of Mackinac.”
- 9.3 Because of distances and age, the women were not willing to travel any distances for a Presbytery-wide gathering. They did not want ZOOM meetings.

- 9.4 Presbyterian Women are not disbanding but will no longer be keeping Presbytery-wide Presbyterian Women Records, except financial. Florence will continue as Communicator and will continue to share relevant information she receives from synod and church-wide PW via the Presbytery website and newsletter. PW Treasurer Sarah Juntune will continue to receive *Mission Pledges; Least Coin, Thank, and Birthday offerings; Honorary Memberships, Theological Education, Presbyterian Hunger and Disaster Relief contributions, etc, and will disburse these funds as designated.
*Mission Pledge offering will be distributed as usual. Unless a church specifies otherwise, 80% goes to support mission projects of Presbyterian Women churchwide (including Horizon Magazine and the exchange programs), and 10% each goes for Mission Projects in the Synod and the Presbytery.
- 9.5 PW Communicator also advised that if you are supporting Mission Workers, it is best to send that support directly to the PC(USA) so you have a personal connection to those people.
